Approval of Agenda for tonight's meeting: Jamie made a motion, second by Jim, motion carried.

Approval of Minutes from Jan 19th meeting: Jack made a motion, second by Jamie, motion carried.

Approval of Minutes from April 20th: meeting: Jim made a motion, second by Jamie, motion carried.

Building & Grounds: Shelby Davis, Principal did presentation/talk about problems with Reuter Hall. Part of the floor is shifting, which may be shifting Limestone. Jeff Mangrich is the new maintenance person and has been discussing and getting bids from companies checking into this. There is a drain problem also-which consists of a break in the line determined by A1 Plumbing. We also got some quotes from Gardner Plumbing and Dalton plumbing with Dalton's being \$1,500. We will make up a list of questions for Mary to present to Jeff and then let him communicate with Dalton. We will discuss findings at the next Meeting.

Regarding the North School Door concrete at the entrance: Shelby has applied for a Grant that could potentially pay for this. We will table this discussion for now.

Jim filled out paperwork for safety inspection that is done every year. That report included exterior signs and lights that were repaired 2-3 months ago.

Finance & Administration: Welcome to our new Parish council members Abby & Joel. Candi Yoder is the new Board of Education representative from our parish but was unable to make it to tonight's meeting. Father hand out statement of Finances.

Community Life/Social concerns: Nothing to Report.

Parish Society: Discussion if we want to hold our Fall Breakfast in October or just do the Roll Sale again. We did discuss briefly, but will discuss more at next meeting, as we will need to start planning in September. And the repair of Reuter Hall floor could factor into the decision as well.

Spiritual Growth & Liturgy: Fr Huber said at IC the misselettes are back in the pews, we could do that here at St Joes also if we would like. Fr Gossman is going to take one Mass each weekend, will rotate every weekend.

New & Unfinished Business: Talked a little about possibly removing the Basketball hoops on the playground. We will discuss more at future meeting.
